Entrepreneur of the Year Nominees

San Antonio and South Texas Winners to be Announced at Annual Banquet

Seven South Texans will be named regional Entrepreneurs of the Year on Wednesday by a coalition of groups that support private enterprise.

The seven will be honored along with the other finalists for the award, at a banquet to start at 6:30 p.m. Wednesday at the Institute of Texan Cultures.

The 13-year-old competition is designed to honor successful entrepreneurs and those who have encouraged them. This year, 22 finalists were chosen from 50 nominees.

The seven finalist will go on to compete nationally for awards.

The competition was begun in 1986 by Ernst & Young, a national accounting and consulting firm. The South Texas regional competition is sponsored by the law firm Fulbright & Jaworski, KENS-TV, Southwestern Bell, Bowne, NationsBank and the San Antonio Express-News.

A panel of judges evaluated the nominees before choosing the 22 finalists in seven categories. The judges were: John C. Brouillard, CAFO, H-E-B; Tino Duran, LaPrensa publisher; Tom Frost, senior chairman of Cullen/Frost; Jan Krug, resident vice president, Merrill Lynch; and Mark P. Mays, president/COO, Clear Channel Communications, Inc.

Other judges were Fred Mills, president/CEO, Baptist Health System; Kay E. Peck, president, P.S. Inc.; Edward Prisco, senior vice president of sales, marketing and new media, San Antonio Express-News; and Mark Watson, Diamond K Ranch.
